Basic Coaching Package

_____ **We would like to choose the \$750 package. This will include:**

1. **Phase One: Prepare Congregation for the Process** - An Orientation Meeting for the Administrative Board or other leaders to teach them about Natural Church Development and the NCD Cycle (no cost).
2. **Phase Two: Do the Survey** - \$100 for the Survey from NCD, \$50 for scoring, and \$75 for a 1 ½ hour meeting to recap the NCD process and administer the survey;
3. **Phase Three: Analyze the Survey Results** - \$150 for 2 - 1 ½ hour sessions with the leadership team/pastor/Implementation Team/30 Survey participants, or any combination of these people to go over survey results, analysis and interpretation the meaning of the scores, and determine next steps.
4. **Phase Four: Develop Action Plan** - \$225 for 4.25 hours of coaching time assisting the Implementation Team in creating a strategic action plan designed to address the church's minimum factor*
5. **Phase Five: Implement & Monitor** - \$75 for one meeting with the coach during the implementation phase of the cycle. This is to assist the implementation team monitor the progress and make any needed adjustments.
6. **Phase Six: Evaluation and Repeat** - \$75 for a final review of process with Implementation Team

_____ **Mileage at 36¢ per mile to and from the church for the coach to be paid directly to the coach. No charge for reasonable telephonic or e-mail coaching, and no charge for copies.**

*Please note that the \$750 package includes 12 hours of time with the coach. On average it takes approximately 12 to 18 hours. **Additional planning sessions may be needed to complete an effective strategic action plan.** If you want the coach present at additional meetings, the costs are based on \$50 per contact hour or \$75 per 1½ hour meeting.

Additional coaching options:

_____ A Friday/Saturday 8-hour Strategic Action Planning Workshop with the Implementation Team and other leaders led by the coach (\$400)

_____ Help with setting up focus groups within the church to gather information and opinions (\$75)

_____ Additional coaching sessions (number to be determined as the plan is created)
