#### DAILY PROCEEDINGS

#### THURSDAY MORNING – JUNE 2

**CLERGY SESSION:** Bishop Timothy W. Whitaker called the Clergy Executive Session to order at 10:05 a.m. Bishop Whitaker welcomed those present and opened the Session with a time of prayer. Bishop Whitaker reminded the clergy members present of their voting rights under the Book of Discipline. Annette Pendergrass, Chair of the Board of Ordained Ministry, moved that members of other Annual Conferences, Local Pastors and Lay Pastors be permitted to have voice, but not vote, during the meeting of the Executive Session. Bishop Whitaker called for the vote and the motion passed. Vicki Walker was nominated as the Chair of the Order of Deacons. Bishop Whitaker called for the vote and she was elected. Bishop Whitaker invited Wayne Wiatt, Chair of the Order of Elders, to speak to the Executive Session. He noted that over 190 Clergy members in the Conference are already involved in covenant groups. Bishop Whitaker invited Vicki Walker, Chair of the Order of Deacons, to speak to the Executive Session. Vicki paid special tribute to the incredible amount of work done by her predecessor, Linda Mobley. The Bishop invited Mike Moore, Chair of the Fellowship of Local Pastors, to speak to the Executive Session. Bishop Whitaker then urged all clergy to become participants in an accountability group. The Report of the Board of Ordained Ministry was given by David Dodge, Executive Director, and Annette Pendergrass, Chair. Disciplinary questions 18, 21, 24, 25, 26, 28, 33, 35, 37, 41, 46, 50, 52, 54, 55, 56, 57, 59, 60, 62 and 83 were presented to the Session for vote. Each of the recommendations made by the Board was affirmed by the Executive Session. Marta Burke raised a question related to those elected for the Committee on Investigation. A motion to reconsider the vote on the Committee on Investigation was made and seconded. The motion passed. A corrected list of those to serve on this Committee was read by Bishop Whitaker. The Bishop called for the vote on the election of the corrected list on the Committee on Investigation. They were elected. LeeAnn Inman made an announcement concerning those assisting in the worship services at the Annual Conference. The members of the Board of Ordained Ministry were recognized for their service. The Bishop led the Executive Session in the singing of “Blest Be the Tie that Binds.” Bishop Whitaker offered the Benediction. The Session adjourned at 11:00 a.m. (See Business of the Annual Conference Report.)

**LAITY SESSION:** The Laity Session of the Florida Annual Conference was convened at 10:00 a.m., June 1, 2005, in Sikes Hall of the Lakeland Civic Center by T. Terrell Sessums, Conference Lay Leader 2000-2004 who introduced William W. Walker, Conference Lay Leader 2004-2008. Mr. Walker announced that an anonymous gift has been made to Florida Southern College for a book a year to be given in perpetuity in honor of Mr. Terrell Sessums. As a part of his introduction, Bill

shared the aspects of his understanding of being a United Methodist Christian. He called upon the laity to assume their role in carrying forward the work begun by John Wesley. This was followed by a collective reading of Ephesians 4:4-6 and a time of meditation. Martha Edens Clark, Chair, Conference Spiritual Formation Team, led the assembly in a responsive reading, "Claiming Our Role as Kingdom Builders." Edie Harris, Conference Spiritual Formation Team, provided an introduction and led a pantomime presentation, "Gifts for the Journey." The Session next expressed its love for the church and for others through an offering to be used by the Board of Lay Ministry in its work during the coming year. Bill Walker stressed the importance of laity being accountable, in partnership with clergy, for achieving the church's mission of making disciples of Jesus Christ. He announced that to assist Lay Delegates in making presentations in their local churches, printed materials, as well as a VHS tape, will be provided. Conferencing provided the laity with opportunities to share ideas and raise concerns. Among the issues raised included communication, particularly the internet; the importance of personal sharing vs. sharing information; the value of clusters; the contributions of Bishop Whitaker; the opportunities of faith-based initiatives; the importance of the laity/clergy partnership; the value of Lay Witness Missions; and the difference between transformed lives and volunteers. Bishop Lloyd Knox led a Service of Retirement for District Lay Leaders. Those retiring at this time are Joyce Waldon Bright, Orlando; Jim Davis, DeLand; Tom Haislip, Sarasota; Dot Collins, St. Petersburg; Joseph Ha, Broward/Palm Beach; Debbie Hawley, Melbourne; Opal Winebrenner, Miami. Bishop Knox and Bill Walker led a Service of Consecration of District Lay Leaders: North West District - Jack Pearce, Lay Leader, Esta Mae Bedenbaugh, Assistant Lay Leader; North East - Ed Chappell, Lay Leader; North Central - Jimmy Garrett, Lay Leader; Gulf Central - Helen Morrill, Lay Leader; South Central - Dick Sargeant, Lay Leader, Leonard Porter, Associate Lay Leader; East Central - Janet Kelley, Lay Leader, Carol Conner, Associate Lay Leader; South West - George Hensley, Lay Leader, Sharon Luther, Associate Lay Leader; South East - Kim Torres, Lay Leader, Bob Holzkamp, Associate Lay Leader. Following the singing of a hymn, Bill Walker gave closing comments and a sending forth. The Session concluded at 11:30 p.m. Others contributing to the Session included Sue Free and Rebecca Renfroe for music, Warren Pattison for graphics, and Don Youngs for sound.

#### THURSDAY AFTERNOON - JUNE 2

**PRE-CONFERENCE MUSIC:** Marcia McFee, Conference Worship Leader, led the delegates in the singing of "Precious Lord, Take My Hand." This was followed by a chorus of "I Am Going to Sing When the Spirit Says Sing." Marcia led the Conference in a moving worship experience to better help us to center our minds and hearts on the presence of Christ. We joined in the singing of "Make Us One, Lord." During the song, the District Superintendents and the District Lay Leaders came forward to pour water into the one fountain that served as the centerpiece for our worship services.

**CONFERENCE CONVENES:** Bishop Timothy W. Whitaker called the Annual Conference to order at 2:10 p.m. Bishop Whitaker welcomed the delegates to Lakeland for this session of Annual Conference. The Bishop offered the invocation. Marcia McFee led the Conference in the singing of the hymn, "And Are We Yet Alive."

**EPISCOPAL ADDRESS:** Bishop Timothy W. Whitaker spoke of the importance of connectionalism as an essential part of the Wesleyan experience. He spoke of the significance of the new clusters that are being formed throughout the Conference. He spoke of the Storm Recovery

efforts and our need to prepare now for future natural disasters to come. He addressed his concern over our membership loss and the decrease in worship attendance, and noted that he will be meeting with each District during the coming year to talk about ways to reverse this trend. He expressed his thanksgiving and praise for the Churches' success in increasing connectional giving. He also highlighted our work in the Cuba-Florida Covenant, our East Angola mission, and our hope for a Haiti Covenant Relationship.

**LAY LEADER'S ADDRESS:** William A. Walker, II, Conference Lay Leader, invited the Conference to stand and join with him in prayer. He expressed his calling to speak to issues that confront large groups and institutions. Our greatest need is to be resolute, disciplined, and willing to serve – in the words of his mother, - “to be Methodists.” He led us in a soul-searching reflection on meeting our calling as a Church with the recurring question, “If to this we believe we are called – then why not?”

**ORGANIZATION OF THE CONFERENCE:** Ken Minton, Conference Secretary, nominated the following persons to assist in the work of the Conference. The nominations were approved.

**BAR OF THE CONFERENCE:** Ken Minton moved that the Bar of the Conference be the entire arena within the bounds of the partition. The motion carried.

**DEADLINE FOR RESOLUTIONS:** Ken Minton informed the delegates that the deadline for submitting Resolutions to be considered at this session of Annual Conference is Friday at 2:00 p.m. By Standing Rule, no Resolution may be received after this deadline.

**REGISTRATION:** Ken Minton reminded the delegates of the importance of registering their attendance. As we will be voting on Constitutional amendments this year, it is important that we have an accurate count of all delegates present.

**MOTION TO ADOPT PROPOSED STANDING RULE:** Ken Minton moved the early adoption of proposed Standing Rule Par. 205. This Rule allows for the cumulative review and adoption of the Daily Minutes on the final day of Conference. This change makes it easier for the members of the Committee on Journal to validate the accuracy of the Minutes prior to adoption. Adopting Par. 205 now would allow the provisions of the Rule to take effect for this session of Annual Conference. The motion carried.

**REPORT OF THE PROGRAM COMMITTEE:** Charles E. Weaver, Assistant to the Bishop, gave the report of the committee. He welcomed the delegates to the Annual Conference. He referred to the report on pages 11-12 of the Conference Workbook. Charles thanked Marilyn Swanson for her extraordinary measure of service. He then directed the Conference delegates to review the Procedures and Agenda Report on page 24 of the Conference Workbook. He thanked Reverend Glenn Mitchell for serving as the Parliamentarian for the Annual Conference. The Bishop called for the acceptance of the report. The report was adopted.

**REPORT OF THE COMMITTEE ON EPISCOPACY:** Jim Kuse, Chair, gave the report of the committee. Jim Kuse referred to the report found on page 117 of the Conference Workbook. He recognized the staff of the Episcopal Office for their excellent service. He then introduced Mrs. Melba Whitaker to the Conference. A gift to the East Angola Mission was given in her honor. Bishop Whitaker was presented with a "CFIJ" shirt in appreciation of his leadership during the past hurricane recovery efforts.

**SPECIAL RECOGNITION:** Bishop Whitaker recognized Dr. Thomas Frank of the Candler School of Theology. He was greeted by the Conference.

**REPORT OF THE STORM RECOVERY MINISTRY:** Marilyn Swanson, Project Director of the Florida Storm Recovery Ministry, gave the report that began with the singing of "Stand by Me When the Storms of Life are Raging" and "Lean on Me." Anne Burkholder, Director of Connectional Ministries, continued with the report. She invited David Harris, Pastor of Trinity United Methodist Church in Arcadia to share some of his personal experiences of the disaster relief response. Tom Hazelwood, Disaster Response Coordinator of UMCOR, reported on UMCOR's response to the people of the Florida Annual Conference. He reported that \$1.9 million had been approved by UMCOR for the Florida Conference hurricane relief. Marilyn Swanson shared several touching stories from around the Conference. During the report, a slideshow of the storm recovery work was presented. The report is found on pages 39-41 of the Conference Workbook. Bishop Whitaker led the Conference in a time of prayer focusing on the work of the storm recovery effort.

**REPORT OF THE TRANSITION TASK FORCE:** Deborah McLeod, Superintendent of the Broward/Palm Beach District, spoke on the process of the redistricting involved in the Connectional Transformation Initiative. (See Reports)

**REPORT OF THE CLUSTER TASK FORCE:** Jeffrey H. Stiggins, Superintendent of the Orlando District, reviewed the Vision Statement of the Conference. Our basic missional strategy for offering new life to the communities of Florida is through the local church. He reviewed the transformational strategy adopted by the Conference. A part of this transformational strategy was the establishment of clusters. What is the purpose of the clusters? It is to improve the effectiveness, fruitfulness, and health of the ministry of the local church. Catherine Price answered the question, "Where do we go from here?" By the end of September 2005, clusters are to be formed. She directed us to the Florida Conference website to find out more about the clustering process. Wayne Curry, Superintendent of the Deland District, gave the room assignments for the "break-out" sessions for each of the new Districts. Ken Minton, Conference Secretary, made several announcements. The delegates were dismissed to their "break-out" groups.

**THURSDAY NIGHT– JUNE 2**

**PRE-SERVICE MUSIC:** Marcia McFee led the delegates in songs of praise – “Awesome God”, “More Love, More Power” and “We Are One in Christ Jesus.”

**GREETINGS FROM FLORIDA SOUTHERN COLLEGE:** Anne Kerr, President, Florida Southern College, brought words of greeting to the Conference. She spoke about the new strategic plan which was approved in May for the future of the college. She noted that the mission of the College is to develop students who will choose to make an impact on society in positive ways.

**GATHERING FOR WORSHIP:** LeeAnn Inman and Jim Rosenberg presided over the worship service. The Service of Word and Table began with the processional hymn “The Church’s One Foundation.” Bishop Whitaker introduced our preacher, Bishop Charlene Kammerer. A time of meditation was led by Marcia McFee, followed by the singing of “You Who Are Thirsty.” The scripture lesson read by Bishop Kammerer was from Ephesians 2:11-18. Bishop Kammerer’s sermon was entitled “Pontifex Maximus.” Pontifex means “bridge builder”. She spoke about the influence of the late Pope John Paul II on people’s lives. She issued a call for all Christians to live as “bridge builders” in today’s world. Following her message, the Conference shared in Holy Communion and Blessing with Oil. The Worship Service concluded with the singing of “In Christ There Is No East or West.” The benediction was offered by Bishop Whitaker. The Service ended at 9:04 p.m.

**FRIDAY MORNING - JUNE 3**

**PRE-CONFERENCE MUSIC:** Marcia McFee led the delegates in the singing of “Leaning on the Everlasting Arms.”

**CONFERENCE EQUIPING NETWORK REPORTS:** Anne L. Burkholder, Director of Connectional Ministries, brought the Report of the Conference Council on Ministries and the Conference Equipping Network in a very creative way. After the presentation, we were directed to pages 30-32 in the Workbook to consider several action items. Recommendation #1 allows for the renewal of the “Statement of Covenant Relationship” with Wesley Group Ministries, Inc. Some corrections were made. The Bishop called for the adoption of Recommendation #1. The Recommendation was approved. Recommendation #2 affirms “the work of the African American Comprehensive Plan Composition Team.” An amendment was offered by Walter Monroe, Jr. and Joreatha Capers. The motion was to “*affirm the work of the African American Comprehensive Plan Composition Team and to be prepared to receive its final proposal at the 2006 Annual Conference. We accept the spirit of the recommendations as noted in the report. However, we understand that this (i.e. pages 33-34) is not a comprehensive plan but merely an outline of a call for a comprehensive plan, a draft of which is to be submitted at the 2006 Annual Conference. We would like to add the following recommendations/amendments:*

1. *that the title of the documents on p. 33-34 be changed to ‘A Call for an African American Comprehensive Plan,’*
2. *that there is a listing of the composition team members,*
3. *that there is inclusion of input from the nine geographical districts*
4. *that there is a clear provision for the inclusion of Black Methodists for Church Renewal leadership in the planning process (in that BMCR is the only nationally Black Caucus of our church),*

5. *that we acknowledge and include the emphases of the national initiative of ‘Strengthening the Black Church for the 21<sup>st</sup> Century’,*
6. *that this plan includes a study of the dwindling presence of African American leadership in the Florida Annual Conference, and*
7. *that this plan includes a comparative study of the trends and lengths of terms of African American appointments.*

*We affirm the theological motifs of relevance and contextual reflection on the themes of hope, healing, wholeness, and social justice.*” Bishop Whitaker called for a vote on the amendment. The amendment was adopted. The Bishop called for the vote on Recommendation #2 as amended. The Recommendation was approved. Anne directed the delegates to review the Conference Advance Mission Specials listing found on page 42 of the Supplement. Several additions were made to the list. June Johns added the correction to the Wesley Group Home Ministries, Inc. The Bishop called on a vote to accept the listing as amended. The list was approved. Anne asked the delegates to review the Resolution on page 43 of the Supplement entitled - “Conference Advance Specials.” Bishop Whitaker called for the vote on the Resolution. The Resolution was approved. Anne presented a Resolution from the Church and Society Ministry Team entitled “Declaring Poverty a Moral Issue and a Legislative Priority.” The Bishop called for the vote on the Resolution. The Resolution was approved. Special recognition was given to Lynette Fields for her years of faithful service.

**SPECIAL GUEST:** Bishop Whitaker introduced Ken Howle from the Lake Junaluska Assembly. He was greeted by the Conference. Bishop Whitaker called for a five-minute recess.

**REPORT ON THE BOARD OF TRUSTEES:** Bishop Whitaker called on Mary Alice Massey, Chair, to speak to the report on page 112 of the Workbook. She reported that the Conference is responsible for \$17.5 million dollars in real property. She recapped the work accomplished by the Trustees over the past year. Bishop Robert E. Fannin was introduced to speak about the Heritage Center project. Mary Alice Massey introduced a motion from the Conference Board of Trustees. The motion reads: *“Be it resolved, that upon approval of the majority vote of the Florida Annual Conference, the Trustees of the Florida Annual Conference in consultation with the Conference Commission on Archives and History, be empowered to negotiate with Florida Southern College regarding a suite in the new archival wing of the Roux Library to house the archives and historical material of the Florida Annual Conference of the United Methodist Church.”* Bishop Whitaker called for a vote on the motion. The motion was approved. Mary Alice Massey expressed her thanks to Leland McKeown, for his tireless fund raising and to First United Methodist Church, Lakeland and Hyde Park United Methodist Church for their generous contributions towards the Leesburg Camp. The full report of the Board was approved. (See Reports.)

**CONFERENCE STATISTICIAN REPORT:** Randy Casey-Rutland, Conference Statistician, recapped the Preliminary 2004 Statistical Report found on page 3 of the Supplement.

**CONFERENCE FINANCE AND ADMINISTRATION REPORT:** Dan Johnson, Chair, presented the Report of the committee. The first item covered was the process by which the recent discovery of a misappropriation of funds by a former staff person in the Risk Management Department was being handled. We were then directed to the Report found on page 99 of the Workbook. Dan noted that apportionment giving had increased from 84.5 % to 87.6%. Dan gave a special word of thanks to the Fort Myers District that, despite being hit so hard by the hurricanes, gave more than 100% of their apportionments. William Fisackerly offered a word of praise and

appreciation for the work of the CF&A during this difficult time. The Bishop offered a prayer of thanksgiving for the generosity of all. (See Reports)

**RECOGNITION OF EXTENSION MINISTERS:** Bishop Whitaker invited Marta Burke to present the report on the work of our ministers serving in extension ministries. She asked those serving in extension ministries to stand. Charles Weaver, Assistant to the Bishop, introduced a video report on the work of our military chaplains in Iraq prepared by Captain Jim Lewis, Chaplain, U.S. Army Reserve. The Bishop spoke highly of the moral leadership being provided by the Chaplains of our armed services. The Bishop then led the Conference in prayer for all those involved in extension ministries all around the world.

**COMMITTEE ON RESOLUTION:** The Bishop called upon Ron McCreary, Chair, to introduce the three ad hoc Resolutions to be considered by the Conference. The resolutions were designated as: #1 - Supplement page 49; #2 - Supplement page 50; and #3 - Workbook page 138.

**CONSTITUTIONAL AMENDMENTS:** Ken Minton, Conference Secretary, explained the procedures for voting on the eight constitutional amendments. The Bishop shared remarks about both the voting process and the amendments themselves as they are presented on pages 134-137.

**ANNOUNCEMENTS:** Ken Minton, Conference Secretary, made a number of announcements. The Conference then recessed until the start of the Memorial Service at 11:00 a.m.

**MEMORIAL SERVICE:** Pre-service music was provided by a violin and piano duet. The words of Greeting and Welcome were offered by Bishop Whitaker. The congregation sang "Christ the Victorious". Bishop Whitaker led the conference in a time of prayer and remembrance. Terry M. Markins, Superintendent of the Leesburg District, brought the message entitled, "They Have Born the Stigmata of Christ" based on Galatians 6:17. The message was followed by the reading of the names of those being memorialized this year. A Prayer of Thanksgiving and Dismissal was offered by the Conference. The conference sang "Holy Ground," and Bishop Whitaker offered the benediction.

### FRIDAY AFTERNOON - JUNE 3

**CONFERENCE CONVENES:** Bishop Whitaker called the Conference to order at 2:30 p.m. The afternoon session began with a procession of banners of local churches celebrating special anniversaries, followed by clergy members celebrating their silver and golden anniversaries of their ordinations. The Bishop offered a prayer of celebration and praise.

**BOARD OF ORDAINED MINISTRY REPORT:** David Dodge, Executive Director of the Division of Ministry, and Annette Pendergrass, Chair of the Conference Board of Ordained Ministry, gave the report of the Board. The Conference was directed to page 76 of the Workbook. Annette Pendergrass dealt with Question 17 -- "Are the pastors blameless in their lives and character?" The District Superintendents responded that all were blameless with the notation that there are three investigations in process at this time. Question 71 -- "Who constitutes the Committee on Investigation for Diaconal Ministers?" Lois Polstra, Phillip Igney The Bishop called for their approval. They were approved. Question 79 -- "Which diaconal ministers have been granted retirement?" Carolyn H. Huber. The Bishop asked for the approval of the Conference. It was approved. The local pastors were called forward to be recognized. Those elected to full connection were called forward that they might answer the historic questions as presented by the Bishop. After

asking the traditional questions, the Bishop continued on with another question - "Will you form covenantal relationships with other clergypersons for mutual support that you may fulfill the vows of your clergy relationship?" Following the examination, Ralph Wrightstone asked a question of the Board of Ordained Ministry concerning the process for those pursuing full connection status. Annette Pendergrass responded on behalf of the Board. (See Reports)

**JURISDICTIONAL CONFERENCE UPDATE:** The Bishop invited Mary Alice Massey to report on the work of the Southeastern Jurisdictional Conference. She reported that among many important accomplishments, six Bishops were elected, including our own Dick Wills. Jerry Carris asked that the Conference send a word of affirmation and encouragement to Bishop Wills as he presides over his first Annual Conference session in the Nashville Episcopal Area. The Conference Secretary will share the sentiment of the Conference with Bishop Wills.

**PRESENTATION OF STANDING RULES:** Sue Hauptert-Johnson, Chair, gave the Report of the committee found on page 149. The Standing Rules could be found on pages 150-190 of the Workbook. The Conference was given the opportunity to ask questions of clarification.

**PRESENTATION OF BOARD OF PENSIONS AND HEALTH BENEFITS:** Scott Baker, Chair, Barbara Pearce, Vice-Chair, and David Dodge, Executive Director of the Division of Ministry, gave the report of the committee. Scott expressed deep appreciation for all those who have assisted in this highly complex work. The report of the Board of Pensions and Health Benefits was found on page 83 of the Workbook. Scott gave an overview of the new plan that will take affect on January 1, 2007. Special attention was given to the needs of the lay employees of the local church. The Board also expressed deep concern over the health of clergy. Barbara Pearce presented more details as to the health benefits of the program. Several Reports were presented for action by the Conference. Report #1 sets the "Past Service Rate" for 2006 at \$649. The Report passed. Report #2 permits the continuation of "Special Grants" to named individuals. The Report passed. Report #3 sets the "Apportionment Recommendation for Pension and Health Benefits Programs for 2006" at \$3,119,820. The Report passed. Report #4 contains the "Housing/Rental Allowance Resolution" for Retired or Incapacitated Ministers of the Florida Annual Conference. The Report passed. Scott introduced the motion found on page 87 of the Workbook regarding coverage of Deacons in Full Connection and Probationary Deacons. The motion passed. Scott presented the Report of the Joint Committee on Incapacity found on page 89 of the Workbook. There was one addition made. The Report was adopted. Scott presented four recommendations from the Board found on pages 90-91 of the Workbook. The four recommendations were approved. A video reflecting the dire need for pension assistance for clergy serving in the Central Conferences was shown. Barbara Riddle brought the Report of the Preacher's Relief Board found on pages 91-92 of the Workbook. The Report was approved. The entire Report of the Board was brought before the Conference and it was approved. (See Reports)

**REPORT OF THE BOARD OF LAY MINISTRY:** William A. Walker, II, Conference Lay Leader, brought the Report found on pages 71-72 of the Workbook. He reported that the Lay Executive Session received an offering of approximately \$3,500 that would be used for the work of the Board of Lay Ministry. He invited Gail Christy-Jones, UMW President, who brought the Report of the United Methodist Women found on page 73 on the Workbook. She emphasized the upcoming mission studies at the School of Christian Mission. Special recognition was given to Cabinet liaison,



Keith Ewing. The Conference Mission Team and members of the UMW were asked to stand. Gayle Hogan spoke to the Report of the Lay Speaking Ministries on pages 72-73 of the Workbook. Rodney Akers brought the Report of the United Methodist Men found on pages 75-76 of the Workbook. The G. Ross Freeman Leadership Award was presented to Douglas Zipperer, Pastor of First United Methodist Church, Brooksville. Bill Walker urged the Conference to visit the laity section of the Conference website.

**SPECIAL GUEST:** Bishop Whitaker recognized Bishop Gustavo Cruz and his wife who are now residing in the Tampa area. Bishop Cruz gave his blessing to the Conference.

**EXAMINATION OF ELDERS:** The Bishop called Chris McNeill and Jeff Oglesby to receive the historic questions for their becoming Elders in the Conference.

**REPORT OF THE BOARD OF HIGHER EDUCATION AND CAMPUS MINISTRY:** John Denmark, Chair, gave the Report of the Board found on pages 63–68 of the Workbook. He invited all of those who had been touched and affected by one of our campus ministries to stand. Jana Hart was recognized for her extensive service to the Board and was presented with the Francis Asbury Award for 2005. The campus ministers offered words of greeting. John Denmark introduced the new Chairperson of the Board, Jay Kowalski.

**UNITED METHODIST PUBLISHING HOUSE:** Bishop Whitaker recognized Gary Thomas of Cokesbury Bookstores who shared with the Conference helpful resources available from the United Methodist Publishing House and Cokesbury. A check from Cokesbury of \$16,701.66 was presented to the Florida Conference which in turn will be given to the Central Conference Pension Initiative.

**REPORT OF THE CONFERENCE COMMITTEE ON LEADERSHIP:** Anne L. Burkholder, Director of Connectional Ministries, directed us to the Report found on pages 6–38, plus the addendum distributed before the afternoon session. Anne recognized those accidentally omitted from the prior report of the Storm Recovery Report. The Report's new format was noted. This year the Report included the nomination of those serving in the new Districts. The whole Report was brought to the Conference, and it was approved. (See Reports)

**CONFERENCE ADJOURNS:** Bishop Whitaker invited Ken Minton, Conference Secretary, to make several announcements. The Bishop asked Pastor Sol Madlambayan to offer the closing prayer in his native language. Bishop Whitaker adjourned the afternoon session at 4:56 p.m.

### FRIDAY NIGHT - JUNE 3

**PRE-CONFERENCE MUSIC:** Marcia McFee led those gathered in the singing of "I've Just Come from the Fountain."

**GREETINGS FROM BETHUNE-COOKMAN COLLEGE:** Bishop Whitaker introduced Dr. Trudie Kibbe Reed, President of Bethune-Cookman College, to share greetings from our United Methodist college in Daytona Beach, Florida. She invited the alumni of Bethune-Cookman to stand. She spoke about the great things that are taking place in the Bethune-Cookman community at this time. She introduced Cynthia Wilson as the new Chaplain of Bethune-Cookman College. Cynthia led the Conference in prayer through song.

**CONFERENCE OFFERING:** Bishop Whitaker invited St. Clair Moore, Chair of the Task Force on the East Angola Partnership, to speak about the offering that would be received at the Service of Baptismal Renewal.

**SERVICE OF BAPTISMAL RENEWAL:** With singing of the songs, “Water, River, Spirit, Grace” and “Wade in the Water,” we entered into a Service of Baptismal Renewal. A liturgical dance accompanied an interpretive reading of “This is the Water” written by Rev. A Robert Hirschfeld and read by Steve Price and Catherine Fluck-Price. A lesson from the Epistle, Ephesians 2:19-22, was read by Bishop Whitaker. The lesson from the Gospel, John 3:1-8, was read. Bishop Charlene Kammerer offered the message entitled, “From Head to Toe.” The offering for the East Angola Partnership was received. #### SATURDAY MORNING - JUNE 4

**PRE-CONFERENCE MUSIC:** Marcia McFee led those gathered in the singing of songs of praise. Bishop Timothy Whitaker opened the session with prayer.

**CONFERENCE CONVENES:** Bishop Whitaker convened the Annual Conference at 8:35 a.m. Ken Minton, Conference Secretary, made several announcements. Tita Parham of the United Methodist Communications staff brought word of multi-media resources of the Annual Conference that will be made available to local Churches.

**NEW CHURCH DEVELOPMENT REPORT:** Montfort C. Duncan, Jr., Executive Director, gave the Report of the Office of New Church Development found on pages 57-59 of the Workbook. David Elyea presented the Report. It was received. Montfort invited representatives of Shepherd Community UMC, and Tim Carson, Pastor, to receive their Charter from Bishop Whitaker. Montfort shared a presentation highlighting several new Church starts. They included Avalon Park (Orlando), Horizons West (Orlando), Korean Mission (Jacksonville), the Studio (Miami), Seville Hispanic, Cornerstone-Haitian (Naples), Palm Bay Haitian, Palm Bay Hispanic, Quincy Hispanic, Greensboro Hispanic, Monticello Hispanic, Live Oak Hispanic, Arcadia Hispanic, Myakka City Hispanic, Center Hill Hispanic, Tabernacle of Refuge (North Lauderdale), and Florida City Hispanic.

**THE HEALTHY CHURCH ACADEMY:** Larry Rankin brought a presentation on the value of life-long learning available through the offerings of the Healthy Church Academy. He noted that all lay and clergy are eligible to take HCA courses.

**ETHNIC MINISTRIES REPORT:** C. Edwin Santos, Executive Director, presented the Report of the Conference’s work in creating new congregations and assisting those ministries already in place that carry on the diverse ethnic traditions within the boundaries of our Conference. He noted that the number of Hispanic congregations has doubled. This is but one of the many indicators of the vitality of New Church Development that embraces the multi-ethnic heritage of this body.

**CONGREGATIONAL TRANSFORMATION REPORT:** Kendall M. Taylor, Executive Director, gave the Report of the Office of Congregational Transformation. The Grindheim-Sims Award in recognition of excellence demonstrated in the work of evangelism in the smaller membership church was given to Wayne C. Stone, pastor of Christ United Methodist Church, Sanford. The Denman Awards in Evangelism were presented to layperson, Jerry Frey, Aloma United Methodist Church, and to clergyperson, E. Dale Locke, Community of Hope United Methodist Church. Mr. Frey was introduced by his Pastor, Bruce Williams. Reverend Locke was introduced by his District Superintendent, Debbie McLeod. Russ Graves, Chairman, presented the Report of the Office of Congregational Transformation found on pages 59-62 of the Workbook. He spoke about the need for continual congregational transformation. Kendall Taylor then spoke about the work of Congregational Transformation and the Church Development Network.

**CONFERENCE IN RECESS:** Bishop Whitaker placed the Conference in recess for five minutes.

**BIBLE STUDY:** Bishop Whitaker called the Conference to order for the Bible Study. The Bishop led the Conference in singing “O For a Thousand Tongues to Sing.” The Bishop then introduced Dr. L. Gregory Jones, Dean of Duke Divinity School, to lead a Bible Study on the Book of Ephesians. This session’s lesson came from Ephesians 3. Dr. Jones emphasized that the Church needs to remember the power of hospitality to strangers and the power of loving our enemies.

**CONFERENCE CONVENES:** Bishop Whitaker called the Conference to order at 10:45.

**REPORT OF THE FLORIDA UNITED METHODIST FOUNDATION:** Thomas Marston, President, gave the Report of the Credit Union found on page 130 of the Workbook. T. Doyle Perry convened the Annual Meeting of the Florida United Methodist Foundation, Inc. He spoke about resources available on the new web site. A video was shown to the Conference regarding Hispanic ministries supported through Foundation grants. They also support the Healthy Church Academy. Grants totaling \$90,000 were given to churches hardest hit by the storms last year. The foundation is the largest, single Conference Foundation in Methodism. The Foundation is moving to a new location which will allow for future growth. The Foundation adjourned at 11:02 a.m.

**REPORT OF THE FLORIDA UNITED METHODIST CHILDREN’S HOME:** Alexander C. Carmichel IV, President, shared the Report of the Florida United Methodist Children’s Home found on pages 123-126 of the Workbook and pages 47-49 of the Supplement. Congregations were asked to send their gifts directly to the Children’s Home. Bishop Whitaker presented Montfort Duncan, Chairperson of the Board of Trustees, with a certificate recognizing the work of the Children’s Home in caring for children and youth. Montfort moved the approval of the statement found on pages 47-48. Anne Burkholder moved to change the words “Conference Equipping Network” to “Committee on Global Missions” on page 48, lines 8 and 12. The statement, as amended, was approved. The entire Report was adopted.

**REPORT OF RISK MANAGEMENT:** Roger Bond brought the Report found on pages 113-116 of the Workbook. He introduced the staff and leadership of the Florida Conference Risk Management Department. He reported that there were 416 claims made during the hurricane season. He directed the delegates to visit the website for more information about the Office of Risk Management. He also encouraged the members to take back one of the information kits available at the Risk Management booth. Those retiring off the committee were recognized for their service. The entire Report was received.

**REPORT OF THE EQUITABLE COMPENSATION COMMITTEE:** David Rawls, Chair, brought the Report of the committee found on pages 92-97 of the Workbook. He moved the adoption of the Minimum Salary Recommendations for 2006. The motion carried. He moved to adopt the change in the Guidelines under Section 2.c). The motion was approved.

**JUSTICE WITH OUR NEIGHBORS MINISTRY:** Bishop Whitaker invited Marilyn Beecher to speak about our new ministry, "Justice with Our Neighbors." This ministry provides legal assistance to our immigrant population. The Bishop expressed heartfelt concerns about certain problems associated with the administration of our immigration laws.

**ANNOUNCEMENTS:** Ken Minton, Conference Secretary, made a number of announcements. Bill Owens brought an announcement about the evening's One Celebration Event. Luc Dessieux offered a closing prayer.

**CONFERENCE ADJOURNS:** Bishop Whitaker placed the Conference in recess at 11:45 a.m.

#### **SATURDAY AFTERNOON - JUNE 4**

**PRE-CONFERENCE MUSIC:** The Florida United Methodist Children's Home Choir treated the delegates to a number of musical selections.

**CONFERENCE CONVENES:** Bishop Whitaker called the Conference to order at 2:00 p.m.

**REPORT FROM SHADE AND FRESH WATER / CLERGY KIDS:** A representative from the Clergy Kids, Miss Sarah Mitchell, brought a Report on the Clergy Kids ministry and then honored Bishop Whitaker by making him an honorary Clergy Kid. Shade and Fresh Water played a video highlighting their ministry.

**PRESENTATION OF SUMMER YOUTH CAMP LEADERSHIP TEAM:** Scott Smith presented those selected to serve on the leadership team for this year's summer camping experience at Leesburg. A team of 90 young men and women will be providing leadership for an expected 3800 campers. Bishop Whitaker led a time of commissioning of the Summer Youth Leadership Team. Scott Smith recognized the fine work of Mike Standifer and Heather Pancoast.

**COMMITTEE ON RESOLUTIONS:** Ron McCreary, Chair, presented the Resolutions to be voted on by the Conference. Resolution #1- Supplement page 49, failed to pass. Resolution #2 - Supplement page 50, was approved. Resolution #3 - Workbook page 138, failed to pass. Ron expressed his appreciation for all who assisted in the handling of these Resolutions.

**CONFERENCE FINANCE AND ADMINISTRATION RECOMMENDATIONS:** Dan Johnson, Chair, and Randy Casey-Rutland, Conference Treasurer, presented the Recommendations to be voted on by the Conference. The report of the Committee is found on pages 99-111 of the Workbook. There are 11 recommendations to be voted on this year. Recommendation #1 sets the formula to be used for determining salaries for District Superintendents. The recommendation carried. Recommendation #2 establishes the mileage allowance for 2006 at 40.5 cents per mile. The recommendation carried. Recommendation #3 establishes guidelines for housing allowances and

Conference owned parsonages. The recommendation carried. Recommendation #4 establishes the “Fair Share Formula” used to calculate apportionments. The recommendation carried. Recommendation #5 establishes the formula to be used for calculating the “District Work Fund” in each District. The recommendation carried. Recommendation #6 reinforces the policy for the expenditure of Annual Conference funds. The recommendation carried. Recommendation #7 establishes the deadline for 2007 Budget Requests. The recommendation carried. Recommendation #8 sets the listing of approved Conference-wide fund raising appeals. The recommendation carried. Recommendation #9 permits the establishment of a “Line of Credit” not to exceed one million dollars. The recommendation carried. Recommendation #10 empowers CF&A to act between sessions of the Annual Conference. The recommendation carried. Recommendation #11 proposes that the worksheet entitled “2006 Budget Summary as Recommended by Action of CF&A” be adopted. The recommendation carried. (See Reports)

**ANNOUNCEMENTS:** Ken Minton, Conference Secretary, made a number of announcements.

**CONFERENCE IN RECESS:** Bishop Whitaker placed the Conference in recess at 3:35 p.m. to reconvene at the 4:00 p.m. Service of Commissioning and Licensing.

**PRE-SERVICE:** Marcia McFee introduced the featured musicians to the Conference. She also took time to express her appreciation for all those who assisted.

**SERVICE OF LICENSING AND COMMISSIONING:** Following the organ prelude, the service began with the Processional Hymn, “God of Love and Power.” Bishop Timothy Whitaker spoke about the significance and meaning of the Service. Psalm 134 was brought to the congregation through song and spoken response. The Epistle Lesson, Ephesians 4:7, 11b-16, provided the text for the Bible Study delivered by Dr. L. Gregory Jones, Dean of Duke Divinity School. The congregation joined in the singing of “Gathered as One.” Bill Walker, Lay Leader, and Annette Pendergrass, Chair of the Board of Ordained Ministry, presented those who were to be licensed and commissioned. Bishop Whitaker asked the candidates the questions of examination. The Conference responded with the singing of “Anointing Fall on Me.” After praying for them, Bishop Whitaker presented each local pastor with their license. The Bishop then commissioned those being received as Probationary Deacons and as Probationary Elders. The Conference joined in prayer for those who were commissioned. The Conference was led in the song, “May You Run and Not Be Weary.” Bishop Whitaker offered the Benediction. All recessed to the song, “My Life is in You, Lord.”

**CONFERENCE ADJOURNS:** Bishop Whitaker adjourned the Conference at 5:35 p.m.

**THE CONFERENCE GATHERED ON THE GROUNDS OF FLORIDA SOUTHERN COLLEGE FOR AN EVENING OF FOOD, ENTERTAINMENT, AND FELLOWSHIP.**

#### **SUNDAY MORNING - JUNE 5**

**CONFERENCE CONVENES:** Bishop Whitaker convened the Conference at 8:35 a.m. He led the Conference in prayer.

**ANNOUNCEMENTS:** Ken Minton, Conference Secretary, made several announcements. Charles Weaver expressed his regrets for the miscommunication concerning the Asbury gathering. The Bishop then made several announcements.

**REPORT OF THE COMMITTEE ON JOURNAL:** Bishop Whitaker called on Terry Wines who reported that the minutes of the previous days have been examined and found to be in order. He moved to adopt the minutes of the previous days' sessions. Bishop Whitaker called for the vote. The motion carried. He also moved that the Conference Secretary be permitted to approve and edit the proceedings of this day after the adjournment of Conference. The Bishop called for the vote. The motion carried.

**DISCONTINUATIONS:** Kendall Taylor brought the Report regarding the discontinuation of congregations. These include by voluntary choice: Peace (Miami), and Lockhart (Orlando). The motion to discontinue Peace on August 15, 2004, carried. The motion to discontinue Lockhart effective July 1, 2005, carried. The following are being closed by recommendation of their District Superintendents. The motion to discontinue Venus (Sarasota) effective June 5, 2005, carried. The motion to discontinue Harris Temple (Tampa) effective December 31, 2004, carried. The motion to discontinue Highlands (Tampa) effective July 1, 2005, carried. The motion to discontinue Woodlands (Tamarac- Broward/Palm Beach) effective June 5, 2005, carried. The motion to discontinue Lakeview Hispanic (Miami) effective June 5, 2005, carried. The motion to discontinue Lakeview (Miami) effective June 5, 2005 was challenged. Following the speeches permitted under the Standing Rules, the Bishop asked Keith Ewing, District Superintendent of the Miami District, to provide the rationale for the recommendation for discontinuance. The Bishop called for a moment of silent prayer. The motion to discontinue Lakeview failed. Kendall Taylor and Bishop Whitaker then led the Conference in a liturgy for the discontinuance of local congregations.

**WHERE WILL THE NEXT CONFERENCE BE HELD?:** Charles Weaver, Assistant to the Bishop, noted the Bishop is appointing a task force to explore possible alternative venues for Annual Conference. He then moved that the 2006 Florida Annual Conference Event be held at the Lakeland Civic Center. Bishop Whitaker called for a vote on the motion. The motion carried.

**REPORT OF THE COMMITTEE ON STANDING RULES:** Sue Hauptert-Johnson, Chair, presented the report of the committee found on pages 150-189 of the Workbook with the amendments found on page 46 of the Supplement. She noted that certain editorial changes as a result of action taken during this session of Annual Conference will be made in the final draft of the Standing Rules. The Bishop called for the vote. The motion carried. (See Reports)

**CONSTITUTIONAL AMENDMENTS:** Bishop Whitaker called for the distribution of the ballots. The Bishop identified those eligible by Discipline to vote, and then called for the vote on each amendment. The results will be published at a later date.

**ANNOUNCEMENTS:** Ken Minton, Conference Secretary, made several announcements. The Bishop called upon Icel Rodriguez to offer a prayer before taking a recess until 10:30 a.m.

**PRE-SERVICE MUSIC:** T.eens L.oving C.hrist Choir of Orange Park United Methodist Church provided songs of faith for the Conference.

**A SERVICE OF RETIREMENT AND ORDINATION:** The processional hymns, “Here I Am, Lord” and “Lift High the Cross,” were followed by the Greeting and Prayer brought by Bishop Whitaker. The Bishop announced that his colleagues, Bishop Robert E. Fannin and Bishop J. Lloyd Knox, would assist in the ordination of the Elders. The offering gathered at this service will go to the Ministerial Education Endowment Fund. Bill Walker, Lay Leader, and Anne Pendergrass, Chairperson of the Board of Ordained Ministry, presented the four candidates. Following the singing of “He Has Made Me Glad,” the Conference recognized the twenty-five retiring servants of God. They represented over 470 years of service. The ritual of the “Passing of the Mantle” was conducted, followed by the Charge by the Conference. Marcia McFee offered a dramatic reading of Acts 27. The T.L.C. Choir offered a contemporary rendition of “I Have Decided to Follow Jesus.” Bishop Whitaker delivered the sermon entitled, “Embarking on a Journey of Ministry.” The Bishop then led in the General Examination of the candidates. 
